1)	Seafarers Registration compulsory for candidates appearing for any Grade of exam.	
2)	All candidates are requested to update their profile on DGS site.	
3)	MEO CL.IV'B'and MEO CL.IV'A' written examination shall be conducted through Online E-Pariksha.	
4)	Last date for fresh applications (online) for Class IV Part A & Part B Examination (written) is 7th MAY, 2019 . Any application made after this date will NOT be reviewed/approved for the month of JUNE - 2019 Editing of any data done by the candidate after 7th MAY, 2019 will not be accepted for examination for the month of JUNE -2019 .	
5)	Candidate for MEO CL. IV Part 'A' and MEO CL. IV Part 'B' have to book their slot themself after obtaining approval in E-Pariksha system from MMD, NOIDA. The slots for seat booking will open on 01/05/2019 and close on 21/05/2019 . The slot will be disabled on 21/05/2019 and no further seat booking would be allowed.	
6)	MEO CL. IV Part 'A' and MEO CL. IV Part 'B' Fresher Candidates are required to book their seat after the successful assesment of their eligibility before 21/05/2019 .	
7)	MEO CL. IV Part 'A' and MEO CL. IV Part 'B' The candidate has to retrieve and print out his admit card after the booking is approved.	
8)	The Oral exam seat booking for MEO CLASS IV PART B would also be open from 01/05/2019 and would remain open till 21/05/2019 After the date no candidate would be allowed to book the oral exam seats. All Written and Oral candidates applying for JUNE-2019 need to mention the intended month as JUNE-2019 .
